

- 6. Organizing/ participation in Joint symposium, seminars, conferences, workshops etc.
- 7. Developing articulations for twinning/joint programs and allowing students to

Undertake part of the programme / course of study at each organization; and

- 8. Promoting such other activities/programs as mutually agreed from time to time
- 3. Commencement, renewal, termination and amendment:-

This MOU will come into force upon affixing of the signatures of the representatives of the both organizations and will remain in effect for three (3) years. This MOU will be renewed upon its expiry, as per mutual agreement of both organizations. If either organization wishes to terminate the MOU at the end of the three years' period or in between the period of three years, it must notify the other organization not less than six months prior to the expiry of the MOU. The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. This MoU, its renewal and the actions taken under it will be reviewed at any time. Modifications to MoU will be made by mutual consent and any amendment or extension to the MoU will be formalized by the exchange of letters and or emails between the two organizations.

4. Resolution of Disputes and Governing Law:-

In the event of any unforeseen issues or matters not covered herein or any controversy, dispute or difference arising out of or in connection with this MoU, the same shall be resolved amicably by both the organizations. This MoU and further agreements will in all respect be governed by and construed in accordance with the laws of Republic of India. This MOU shall be signed in counterpart. Memorandum of Understanding On Exchange of Staff/Faculty

Between

Netaji Subhas University, Jamshedpur



&

Smt. Kamla Devi Gauridutt Mittal Mahila Mahavidyalaya, Sardarshahar (Churu) Raj.







This Memorandum of Understanding (MoU) is effective as of 21.02.2023 to establish an affiliation by and between

Netaji Subhas University, Jamshedpur, Jharkhand First Part,

And

Smt. Kamla Devi Gauridutt Mittal Mahila Mahavidyalaya, Sardarshahar (Churu) Raj. Second Party,

The aforesaid institutions are hereinafter referred to individually as *institute* and collectively as *institutes*.

Preamble

WHEREAS, NSU and SKDGDMMM, Sardarshahar have many areas of common interest in multi-disciplinary knowledge sharing among faculties for considerable advantage may be gained from their pursuit on acollaborative basis in the fields of academics, education and research. NOW THEREFORE NSU and SKDGDMMM, Sardarshahar, have decided to enter into this Memorandum ofUnderstanding (hereinafter referred to as MoU), which defines the framework for thecooperation of the two higher education institutes set out in the following sections.

ARTICLE 1: OBJECT

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest. The two institutions shall seek to promote:

A. Faculty/Staff Exchanges

- (I) The exchange of faculty to the mutual benefit of both institutions,
- (II) Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
- (III) The exchange of academic materials and publications,
- (IV) Conducting lectures,
- (V) Undertaking joint research,
- (VI) Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills,
- (VII) Participating in seminars, symposiums, and other types of academic discussions,
- (VIII) Co-supervising post-graduate students,
- (IX) Conducting study tours and joint consultancy work.

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed.

B. Other Areas:

- (I) To exchange information on research and educational programs,
- (II) To exchange information on teaching, learning material and other literature relevant to their educational and research programs,
- (III) To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participatetherein,
- (IV) To organize jointly seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein.
- (V) To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty toparticipate therein.
- (VI) To exchange, on a reciprocal basis, students at Undergraduate and Postgraduate for limited periods of time for purpose ofeducation and /or research,
- (VII) The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes,
- (VIII) To use laboratory facilities in specific cases for a limited period,
- (IX) To permit students, staff and faculty members to use library facility.

NSU and SKDGDMMM, Sardarshahar agree that detailed terms and conditions that guide each activityidentified above will be determined separately and agreed upon by the twoinstitutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty tocoordinate the programme on its behalf. Further, a coordination committeeconsisting of a programme coordinator from the side of SKDGDMMM, Sardarshahar and a programme coordinator from the side of NSU, Jamshedpur will periodically review and identify ways tostrengthen cooperation between the two Parties.

ARTICLE 3: CONFIDENTIAL INFORMATION

Both the parties of the MOU's does not absolve any confidential information during the research activity.

ARTICLE 4: VALIDITY

The Memorandum shall remain in force for a period of 2 years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 5: TERMINATION

Once terminated, neither NSU nor SKDGDMMM will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, NSU and SKDGDMMM will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

ARTICLE 6: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by therepresentatives of both parties.

ARTICLE 7: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the Parties.

ARTICLE 8: LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating any legal relationship between the parties. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

ARTICLE 9: DISPUTE RESOLUTION

In case, there be a dispute relating to any aspect of academic cooperation, Registrar NSU and SKDGDMMM, Sardarshahar will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

NSU and SKDGDMMM, Sardarshahar welcome the establishment of this Memorandum for cooperation andjointly agree to the provisions as set out above.
