### ARTICLE 2: COORDINATION

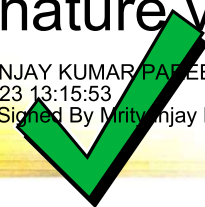

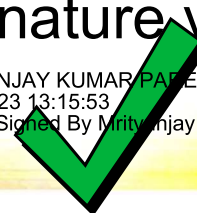
